- 1. Call to Order: 6:06 PM

- 3. Review and Approval of July Minutes
 - 1. Minutes may have been emailed out, but do not seem to have been uploaded to the QTK drive. July Minutes will be uploaded prior to September's meeting, and the Minutes will be reviewed and approved at that time.

- 5. First show, Blcycle, will open in mid-October
- 6. Report from Associate Executive Director
 - 1. Financial reports addressed
 - 1. Monthly activity
 - \$1448.38 corporate contributions (change for change) came in
 - 2. \$75 recurring donation came in
 - 3. \$75 rent went out
 - 4. \$85 Quickbooks fee
 - 5. Accounting fee
 - 6. Total of \$1100 gain on the month
 - 2. Total
 - 1. \$11,370.51
 - 1. \$4500 of this is restricted for the Shedding the Antlers show.
 - 2. Total assets need to be evaluated and reviewed by CK and CH to ensure they are worth what we have them recorded
 - 2. Board member donations will be tracked separately from other contributions
 - 3. Grants being written/sought
 - 1. CH asks for any stories or narratives
 - 1. 3 with quick deadlines, others that are more open-ended
 - 2. Gilmore Foundation
 - 1. Smaller ask than what we had been planning to ask for, but is precisely what we budgeted for
 - 2. Quicker turn around
 - 3. Dalton Foundation

- 4. Upjohn Institute
 - 1. Contacted them, will have phone call tomorrow to determine what will be an appropriate ask will be
- 5. Kalamazoo Community Foundation's LGBT Equality fund
 - 1. 20 days out, this is more time-sensitive
 - 2. \$5000

- 1. MV gives update on work that MV & ML have done
 - 1. Originally followed HJ's vision and intention getting the minimum viable option launched ASAP
 - 2. Have ideas about what should be launched in the next few months, but will add to that list following the workshop on September 23.
 - 3. Submissions have already been received for individuals looking to be on "newsletter," "email blast," or whatever we decide to call our regular or semi-regular update.

8. Board recruitment

- 1. MCY present at meeting.
 - 1. Fan of theater.
 - 2. Has background in non-profit structure, revising documents to make them more inclusive, writing mission statements, strategic planning, and some small experience in grant writing.
 - 3. Is currently a work-from-home project manager.
 - 4. Recently moved to Kalamazoo, having lived on the West Coast for several years.
 - 5. After MCY left meeting, vote was taken as to MCY's recruitment to the board:

 - 2. MV second

 - 4. KL will reach out to MCY with offer to join the Board this evening
